Message from the President

There come times in the life of an organisation like our college where one decision will have a large effect on its future; impacting its influence, scope

and vitality. Such a time came upon us recently, we liked it or not and the decision was not in our hands. On the 14th of May the Council of the Academy of Medicine took that decision to make the Otorhinolargyngology chapter of our college the College of Otorhinolaryngology an independent college within the Academy. As your president I believe it is my duty to inform you adequately and believe I need to give most of my address to you as president to it.

On 30th August 2021 the President of the MSOHNS sent me and the Master of the Academy of Medicine a letter requesting permission to form a college under the Academy. Although officially the MSOHNS is not part of the Academy and many of their members are not in the college, nevertheless the MSHOHNS speaks for members in the ENT Chapter of our college. This matter has a history dating back to 2015 when a member of the Academy council who was an ENT surgeon expressed the desire to have a college of ENT surgeons. The subsequent discussion and minutes of meetings on the matter are available for your perusal. We must note that this request did not originate from within our college but went to the Academy our parent body, as we had no chapters within the college at that time.

A reading of these proceedings will show that the ENT surgeons were told to first join the Academy through the College of Surgeons and subsequently when they have enough members and have activities in sufficient levels that such a college can be formed. As Professor Dr Looi Lai Meng the Chairman of the Constitution review

committee of the Academy of Medicine put it. A reading of the minutes indicates a 'gentleman's agreement was given' to that effect.

In the letter dated 30th August 2021, the President of the MSOHNS expressed the belief that with 118 ENT members and a chapter that was formed in 2018 the time had come. The council of the College of Surgeons met on 12th September 2021 and decided to meet the leaders of the MSOHNS for a dialogue with the aim to convince them that in view of founding aims of the College of Surgeons "to be an association for all surgeons and specialists in allied disciplines in Malaysia" and in addition, to that end "to be the sole body within the Academy of Medicine of Malaysia responsible for all matters pertaining to all disciplines of surgery", that we should remain united as one college. In addition, developments in the college such as activities that cross specialty disciplines such as minimally invasive surgery, trauma, professionalism and training are common ground for all surgeons.

The dialogue meeting was held virtually on 19th September and the minutes were recorded. Subsequent to that the council of the College of Surgeons met on 9th October to reflect on the meeting and subsequently wrote to the chairman of the ENT Chapter and the President of the MSOHNS on 14th October to ask for the reason for leaving the college and advantages of forming a separate college.

The college received a reply on 12th January 2022. It is a long letter and I cannot summarise it for you here. The sentiment and decision of the present and three past presidents of the MSOHNS was that they believed 'Otorhinolaryngology is an independent field with very different practices from surgeons'.

The council of the College of Surgeons then met on 15th of January and did not support that request but realised this decision also involved the Academy of Medicine. It was the Academy that would have to decide whether to the formation accept of College Otorhinolaryngologist and Head and Neck Surgeons or of Otorhinolaryngology. From the name of the specialty, including head and neck surgery it appears they are surgeons. Surgery of the thyroid gland and tracheostomy, for example, are two areas that overlap and to have two colleges wanting to govern these areas might pose problems.

The council of the Academy of medicine met on 27th February and was briefed by Prof Looi Lai Meng the chairman of the Constitution Review Committee. The minutes of that briefing are long but very important to our consideration. After discussion, the Master insisted that a vote should be taken regarding this request.

There was a matter raised that the Academy has yet to draw up its guidelines for the criteria for forming colleges. That need was recognised some time ago but that work has not been done and therefore a decision would be on an ad hoc basis and a precedent that affects the future. There was a proposal then that this decision to form a college of ENT be postponed till such guideline are drawn. However, the Master denied it saying the matter has dragged on long enough. A vote was then taken and the majority of the council endorsed the formation of the ENT college.

Do we have any recourse do we have? At that time I thought there is actually a clause within the Constitution of the Academy that we could exercise And in fact Professor Dr Looi noted that in her report to the AMM council. Clause 5 of the Constitution she noted, said "For a specialty already under an existing College/Chapter, the application for formation of a new College/Chapter will require the approval of the parent College/Chapter." However, I was later informed that the Amended Constitution of the Academy date 2017 had that clause

removed. What is left then is clause 1 of that section which states

The Council (of the AMM) may at its discretion create or establish Colleges/Chapters in any of the medical specialties. The Colleges/Chapters thus created will establish regulations pertaining to each of the specialties. All such regulations and rules shall be subject to the approval of the Council.

I take this opportunity to inform you of this because I believe this house should know what the constitutional dictates are and that they have been adhered to. As I said in the beginning, it was a decision which was not in the hands of the College. On reflection, if the council of the Academy took a vote to decide it would seem odd if a college could veto that decision. Clause 1 said, as is necessary that the Council of the Academy is the body to decide to form a new college and that decision cannot be challenged.

I would like at this point to wish our ENT colleagues our best wishes as they embark on their journey as an independent college. I hope they have benefitted from their presence in our college up to date. The council has had good experiences working with our ENT colleagues over the years in academic activities and One of their number, Professor Dr Goh Bee See has actually been on council the last 2 years. The regulations dictated that she is now a member of the new ENT college and so she has resigned her place in our council. On looking at our By-Laws and Constitution the current council decided that we should fill that vacancy for one year until the election for that vacancy is due. The council met and has invited Professor Dr Azlina Abbas, to fill that vacancy and she has accepted it. I want at this point the thank Prof Goh for her contributions to the College and to give her our best wishes and wish Professor Dr Azlina a fruitful time serving with us on the council.

But now I must focus on the future. Our college has in its first aims, as I said, to be to be an association for all

surgeons and specialists in allied disciplines in Malaysia" and in addition, to that end "to be the sole body within the Academy of Medicine of Malaysia responsible for all matters pertaining to all disciplines of surgery". I have spoken about how we wanted to but were not able to do that in this past instance. But the bigger question is why do that at all? All I said above were procedural matters. Behind that there must a 'logos' or a reason for doing this. Why keep surgeons together? It is the stated aim of the college. It was framed when the college was formed. But why? Why hold on to something if there is no purpose. But I believe there is.

I have stated most of this in my message in the newsletter in December 2021. I would encompass it all under the theme we are STRONGER TOGETHER. But I feel compelled to say something about my vision here. It is no point leading an organization if one does not have a vision for it. So if you will indulge me I would like to close with a few remarks about my vision for the college.

There is a danger for surgeons to become trapped in silos to the detriment of the profession and our patients. As specialization develops technology had led to disciplines like neurosurgery, urology, cardiothoracic surgery, orthopaedics several more disciplines that have so much knowledge a specialist would require that he or she excludes the practice of other areas of surgery. At the same time, however, as technology develops more tools such as minimally invasive tools that the neurosurgeon, the ENT surgeon and the general surgeon finds a niche to use them in each particular field. Some neurosurgeons may then specialize into a narrower area of minimally invasive neurosurgery. We can form many, many small pockets like this where are minimally invasive paediatric surgeon for example only seeks to conference with other minimally invasive paediatric surgeons. Have they no common ground with surgeons interested in minimally

invasive surgery in urology? Specialization we use as a good word. The bad word is fragmentation and working in silos. We must not be blind to the benefits of working across disciplines and must have the institutions and tools to negotiate this future and I believe a united college would help.

There are other areas of common interests among surgeons. Training a urologist or a cardiothoracic surgeon would require skills in teaching and structures that have commonality. We don't have to be fragmented and each develop the training programmes and skills for teaching entirely on our own. Then again, there is trauma. The injured patient often has injury to the pancreas together with a fractured vertebral column and chest injury. Would we have 3 or 4 specialists in trauma who study trauma related to their own area of the anatomy only? Or even surgeons in 8-9 disciplines with independent interests in trauma? How should trauma surgeons best manage a patient? I am sure they should meet and conference, and we must have the institutions that facilitate this. In the college of surgeons of Malaysia we have chapters like these that cut across disciplines and I am so please they can grow. The shape of surgical practice may be quite different in the future when we can look back many years from now and I believe they will be better served if we have a college that enables all surgeons to engage together.

This is the college that I would hope to work for and I hope we all aspire to that. We allow and encourage all chapters within the college to be as active as possible and encourage activities in related specialist societies which may need to cater for member who are not eligible to be member of our college because they are not surgeons, such as allied health professionals. But as a college we promote and safeguard the interests of surgeons and stand united because We will be stronger together.





Chapter of Thoracic & Cardiovascular Surgery

National Curriculum in Cardiothoracic Surgery

The Cardiothoracic Surgery National Curriculum was launched by the Director-General of Health on 27th May 2022. This sets the standards for cardiothoracic surgery training in the country. It will be an important resource for both trainers and trainees as well as regulatory bodies.

Parallel Pathway Training

An MOU was signed on 27th May 2022 by the Academy of Medicine of Malaysia, the Malaysian Association for Thoracic and Cardiovascular Surgery (MATCVS), Universiti Malaya (UM), the Royal College of Surgeons of Edinburgh (RCS Ed) and the Ministry of Health formalising the arrangements for parallel pathway training in cardiothoracic surgery in Malaysia. All parties will jointly organise the training with quality assurance to international standards and the exit examination provided by RCS Ed. UM will provide the certificate of completion of training to all trainees who successfully complete their training. 32 trainees are currently undergoing cardiothoracic surgery training through the parallel pathway in the Ministry of Health, IJN and UM.



RCS Ed Joint Specialty Fellowship Examination in Cardiothoracic Surgery

The RCS Ed Joint Specialty Fellowship Examination in Cardiothoracic Surgery was held simultaneously in Kuala Lumpur and Hong Kong from 28th - 29th May 2022. Examiners were appointed by the RCS Ed from the UK, Malaysia, Singapore and Hong Kong. Eight trainees from the Cardiothoracic Surgery Parallel Pathway Training passed the exams. The trainees were sponsored by the Ministry of Health, Institut Jantung Negara (IJN), UM, and the Brunei government. All the eight trainees will be completing their training in Cardiothoracic Surgery in the next year. In addition to the eight successful trainees from the Cardiothoracic Surgery Parallel Pathway Training, one successful trainee from Singapore and two from Hong Kong also passed the exams. All the successful candidates will be awarded Fellowship of the Royal College of Surgeons

of Edinburgh (FRCS Ed) in the Specialty of Cardiothoracic Surgery.

22ND MATCVS Annual Scientific Meeting

The 22nd MATCVS Annual Scientific Meeting will be held from 1st - 4th September 2022 at the Shangri-La Kuala Lumpur in conjunction with the 2nd Annual Meeting of the Asian Association for Paediatric and Congenital Heart Surgery. An exciting program has been planned over the 4 days covering Cardiac Surgery, Aortic Surgery, Thoracic Surgery, Congenital Heart Surgery, Paediatric Cardiac Surgery, Cardiothoracic Critical Care, and Perfusion, amongst others. Abstract submissions are invited for oral and poster presentations with prizes for the best presentations.



Aortic Dissection Symposium

An Aortic Dissection Symposium will be held at the Borneo Convention Centre in Kuching, Sarawak, from 14th - 15th December 2022 organised by the RCS Ed, MATCVS, CSAMM Chapter of Thoracic and Cardiovascular Surgery, and the Academy for Silent Mentor as part of the Tripartite Conference on Healthcare Challenges in the 21st century. An international faculty from the USA, UK and Malaysia will be participating. In addition to presentations and lectures by the expert faculty, a cadaveric workshop on aorta surgery will be held on 13th December 2022 at University Malaysia Sarawak. A public awareness on Aortic Dissection will also be launched during the symposium.

The Chapter of Minimally Invasive Surgery

After a petition for the establishment of a cross-specialty Chapter of Minimally Invasive Surgery, the College Council consented to its establishment with the first AGM of the Chapter taking place after a successful inaugural webinar which took place online on the 18th and 19th December 2021. The inaugural webinar had 396 registrants and enjoyed good attendance throughout. As organiser. I like to acknowledge the support of the college council and all the contributions from overseas and local faculties in upper and lower GI, hepatobiliary, bariatric, breast & endocrine, cardiothoracic, paediatric and urological surgery. Contributions from faculties outside the college, notably gynaecology, radiology, anaesthesiology and pathology are also acknowledged. The Webinar received a total sponsorship of RM 27,000 from related industry and the Chapter is very grateful for their generous support and look forward to future collaboration. Vascular Society of Malaysia (VSM) Activities

The year 2021 was the continuation of the COVID-19 pandemic. As a result of that, almost all physical scientific conferences or seminars were held online or hybrid. The Vascular Society of Malaysia (VSM) has initiated several online activities for members as well as for fellows of vascular surgery.

1. Monthly VSM Webinars

VSM started its monthly 2-hour webinars on various topics in vascular surgery. It entailed different aspects of vascular surgery from various pathologies in aorta, peripheral arterial disease to venous issue. Vascular access issues such as arteriovenous fistula management and update was also discussed in detail. We have invited several renowned experts in their respective field, both local as well as from overseas, to sit as panelists in the topics discussed. The consultants invited included interventional radiologist, neurologist, nephrologist, cardiothoracic surgeon, statistician and legal expert. It has received very good review with lively discussion during the webinars.
